**Said Adejumobi** (Nigeria) is Associate Professor of Political Science at Lagos State University, Nigeria, and Political Governance Adviser to the Economic Community of West African States (ECOWAS). He was previously a Governance Consultant to the United Nations (UN) Economic Commission for Africa during the preparation of the African Governance Report. He has written extensively on governance, conflict and security studies, including *Breaking Barriers, Creating New Hopes: Democracy, Civil Society and Good Governance in Africa* (Africa World Press, 2003, co-edited with A. Bujra), *Leadership, Civil Society and Democratisation in Africa: Case Studies from Eastern Africa* (Development Policy Management Forum, 2002, co-edited with A. Bujra), *The National Question in Nigeria* (Ashgate, 2001, co-edited with A. Momoh), *The Nigerian Military and the Crisis of Democratic Transition: A Study in the Monopoly of Power* (Civil Liberties Organisation, Lagos, 1999, co-edited with A. Momoh) and *The Political Economy of Nigeria under Military Rule, 1984–1993* (Southern Africa Political Economy Series, 1995, co-edited with A. Momoh). He has held fellowships from Columbia University, New York; the Norwegian Nobel Institute; the Social Science Research Council, New York; and the University of Cape Town; and was a visiting scholar at Aalborg University, Denmark.

**Anatole Ayissi** (Cameroon) is the political adviser to the Special Representative of the UN Secretary-General for West Africa. He was previously Head of the Programme on Peace-building and Practical Disarmament in West Africa at the UN Institute for Disarmament Research (UNIDIR) and worked for seven years as a disarmament expert for the Cameroonian Ministry of Foreign Affairs. He has been a Fulbright Fellow at the Political Science Department of the University of Pennsylvania and a Research Fellow at the University of Paris II, Panthéon-Assas. He has published extensively on disarmament, post-conflict recovery and peace-building in Africa, including *Bound to Cooperate: Conflict, Peace and People in Sierra Leone* (UNIDIR, 2000, co-edited with R. Poulton); *Cooperating for Peace in West Africa: An Agenda for the 21st Century* (UNIDIR, 2001); ‘Protecting children in armed conflicts: from commitment to compliance’, *Disarmament Forum*, 2002; ‘L’ONU et la paix en Afrique’ [The United Nations and peace in Africa], *Questions Internationales*, no. 5, 2004; and *Combating the Proliferation of Small Arms and Light Weapons in West Africa: Handbook for the Training of Armed and Security Forces* (UNIDIR, 2005, co-edited with I. Sall).

**Nicole Ball** (United States) is a senior fellow at the Center for International Policy, Washington, DC, and a Visiting Senior Research Fellow at the Center for International Development and Conflict Management, University of Maryland. She is a member of the Advisory Group of the SIPRI/African Security Dialogue and Research Project on Military Budgetary Processes in Africa. She has worked extensively on issues relating to democratic security sector governance, particularly financial management, since 1978. She is co-editor of *Security Sector Governance in Africa: A Handbook* (Centre for Democracy and Development, 2004, with 'K. Fayemi) and co-author of *Enhancing Democratic Governance of the Security Sector: An Institutional Assessment Framework* (Clingendael Institute for the Netherlands Ministry of Foreign Affairs, 2003, with L. van de Goor and T. Bouta).

**Mesfin Binega** (Ethiopia), a retired commodore of the Ethiopian Navy, is currently Head of the Administrative Control and Management Centre of the African Union's Darfur Integrated Task Force. He has been with the AU since 1996, acting during that time as a military consultant and as the officer in charge of budget preparation and administration, and of logistics planning for AU peace support operations. He was involved in the deployment of the AU's African Mission in Burundi and the AU Mission in the Sudan. While on active service he was, successively, Deputy Head and Head of the Main Department of Budget Planning of the Ethiopian Ministry of National Defence and economic adviser to the ministry. He is a member of the SIPRI Military Expenditure Network.

**Adedeji Ebo** (Kenya) is a Senior Fellow and Coordinator of the Africa Working Group at the Geneva Centre for the Democratic Control of Armed Forces (DCAF). He was previously Associate Professor and Head of the Department of Political Science and Defence Studies at the Nigerian Defence Academy, Kaduna, and Guest Lecturer at the Nigerian National War College, Abuja. He has been consultant to the Small Arms Survey, Geneva, and International Alert, London. His research interests include peace and security in Africa, small arms in West Africa and security sector governance.

**Osman Gbla** (Sierra Leone) is a Senior Lecturer and Head of the Department of Political Science of Fourah Bay College, University of Sierra Leone. *Wars, Child Soldiers and Post-Conflict Peace-building in West Africa* (ed. A. Sesay, College Press, 2003). His research interests include conflicts and post-conflict peace-building, security and security sector reform, and governance in Africa generally and West Africa in particular. He is a member of the SIPRI Military Expenditure Network.

**Eboe Hutchful** (Ghana) is Professor in Africana Studies at Wayne State University, Detroit, Michigan, and Executive Director of African Security Dialogue and Research (ASDR), Accra, Ghana, and is the co-coordinator of the SIPRI/ASDR Project on Military Budgetary Processes in Africa. He has taught at several other universities in Africa and North America, including the University of Toronto, the University of Port Harcourt and the University of Ghana. His research has been primarily in the areas of militarism and security sector reform and the political economy of adjustment, areas in which he has published extensively. He is the author and co-editor of a large number of journal articles and several books, including *The Military and Militarism in Africa* (CODESRIA, 1998, co-edited with A. Bathily); *Ghana's Adjustment Experience: The Paradox of Reform* (James Currey, 2002); and a forthcoming volume, *Governing Security Establishments in Africa* (with A. Lala). He is current Chair of the African Security Sector Network.

**Julius Karangi** (Kenya) is a Lieutenant General in the Kenya Air Force (KAF). Since August 2005 he has been Vice-Chief of General Staff. Prior to that, he was Commander of the KAF and Commandant of the Defence Staff College, Karen.

**Len le Roux** (South Africa) is the Head of the Defence Sector Programme at the Institute for Security Studies (ISS), Pretoria. He served in the South African military for 36 years and, as the Director Strategy for the South African National Defence Force and the South African Department of Defence (DOD) from 1995 to 1999, he was involved in the development of the 1996 White Paper on defence, the 1996–98 Defence Review and the DOD Transformation Project. After leaving the DOD in 2000 he has remained active in the security debate in Africa by supporting the programmes of various non-governmental organizations and universities.
